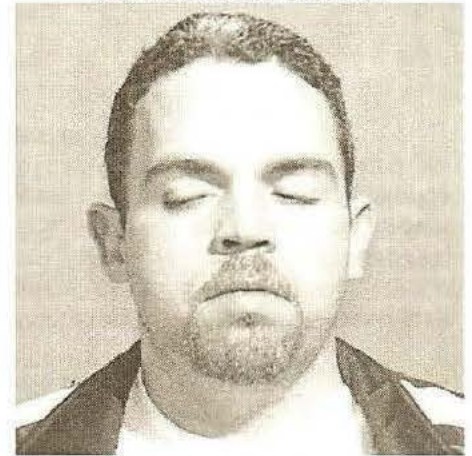
REMINDER
