DEPARTMENT GENERAL ORDER NO. 61-43

SUBJECT: Activation of a 6th Traffic Area.

## I. PURPOSE

- A. This order activates a 6th Traffic Area.
- B. The Traffic Area Headquarters located at 3801 North Damen Avenue, will henceforth be known as the 6th Traffic Area.
- C. A Traffic Area Headquarters will be established at the 32nd District station, 2138 North California Avenue and will be known as the 5th Traffic Area.
- D. Traffic Area Headquarters Nos. 1, 2, 3, and 4 will remain at their present locations and retain their numerical identity.

## II. TRAFFIC AREA BOUNDARIES

- A. Traffic Area No. 1, for the present, will continue to provide service in the 1st, 22nd, 26th and 35th Districts and on Lake Shore Drive, from Oak Street to 31st Street and on Congress Expressway from Ashland Avenue to Columbus Drive.
- B. Traffic Area No. 2, for the present, will continue to provide service in the 5th, 6th, 7th, 8th, 9th, 10th and 12th Districts, and on Lake Shore Drive from 31st Street to 67th Street.
- C. Traffic Area No. 3, for the present, will continue to provide service in the 13th, 14th, 15th, 16th, 17th, 18th, 19th and 20th Districts.
- D. Traffic Area No. 4, for the present, will provide service in the 23rd, 24th, 25th, 27th and 28th Districts and on Congress Expressway from Ashland Avenue to Austin Boulevard.
- E. Traffic Area No. 5, will provide service in the 29th, 30th, 31st, 32nd, 33rd and 34th Districts and on the entire Northwest Expressway.
- F. Traffic Area No. 6, will provide service in the 36th, 37th, 38th, 40th and 41st Districts and on Lake Shore Drive from Oak Street to Hollywood Avenue.

## III. RADIO FREQUENCY

All traffic cars assigned to Traffic Area No. 5, will receive their radio assignments on the North Frequency. All other Traffic Areas will continue to receive on their present bands.
